

PROVISIONS FOR ANNUAL GOLF MEMBERSHIPS

1. All annual golf memberships are valid from January 1, 2020 until December 31, 2020.
2. Annual golf memberships must be paid in one payment and included with the application.
3. Annual golf memberships are non-refundable and nontransferable.
4. Annual golf members may purchase a reduced Cart Fee for \$14 per member per round.
5. Annual Golf Memberships allow play only at John F. Byrne in accordance with the designated days and times for the membership plan that is purchased.
6. Permits are not valid during tournaments, outings, leagues, or any other contracted events.
7. In submitting an application for an annual golf membership, the purchaser agrees to abide by the rules and regulations and conduct themselves in a proper manner at all times. Breach in these rules can result in the loss of privileges and forfeiture of membership fee paid. Copies of Rules and Regulation are available at all time in the clubhouse.
8. Prior to beginning each round of golf, All Annual Members MUST: Register in the Pro-Shop, Present his or her Membership Card, Proper Photo ID, Receive a Receipt and Present the Receipt to the Starter.
9. John F. Byrne Golf Club reserves the right, at it's discretion, to close the course due to bad weather, golf outings, special events, or other conditions. In the event of lightening, or any other rapidly changing weather conditions, all players on the course should cease play and exercise good judgement. Players play at their own risk. There is no lightening detection system monitoring weather conditions and alerting players.
The purchaser as a condition of permit use, agrees to indemnify and release John F. Byrne Golf Course, The Fairmount Park Commission, The First Tee of Greater Philadelphia and the City of Philadelphia (and em-ployees from all entities), from and for all liability of personal injury or loss/damage to property or person by purchasers use of the golf course and any related facilities, whether such injury to purchaser, his/her property or to third parties and their property. The purchaser understands that golf can be a dangerous sport; that rocks, holes, various terrain, repair areas, and many other hazards and obstacles exist on a golf course and such dangers are recognized and accepted whether marked or unmarked. The purchaser realizes that accidents occur and injuries may result, and therefore, assumes all the risks involved with playing golf.

Annual memberships include access to practice facilities as available and a reduced cart rate of \$14. Annual memberships expire the last day of the calendar year. Annual memberships are ONLY valid at the John F. Byrne Golf Club.

UNLIMITED FEE **\$1260.00**
Golf privileges are unlimited 7 days a week.

LIMITED FEE: **\$925.00**
Golf privileges are limited to weekday play (Mon.- Fri.) and after 12 p.m. on weekends and holidays.

TWILIGHT FEE: **\$800.00**
Golf privileges are limited to play after 12 p.m. 7 days a week.

WEEKDAY FEE: **\$675.00**
Golf privileges are limited to weekday play only (Mon-Fri). Greens fee must be paid on weekends and holidays.

WEEKDAY SENIOR FEE: **\$600.00**
Golf privileges are limited to weekday play only (Mon-Fri) for customers 62 years and older at the beginning of the calendar year January 1st, 2019. Greens fee must be paid on weekends and holidays.



STUDENT FEE **\$400.00**

For currently enrolled students. Must be 23 years old or younger at the beginning of the calendar year January 1, 2019. Golf privileges are limited to week-day play (Mon.- Fri.) and after 4 p.m. on weekends and holidays

PRACTICE FEE: **\$125**

Golf privileges are limited to Learning Area and Practice Green
